Background/Discussion:

This budget amendment is to adjust the total funds available, and likely to be spent in FY2024-2025, for one-time funds rolled over from last fiscal year (2023-24) which are designated for reimbursement to Anderson-Geneva for environmental remediation expenses as well as any TIF payments or other previously owed reimbursements.

Fiscal Impact:

This is an increase in revenues and expenses of \$3,079,657 from \$34,208,591 to \$37,288,248. These funds represent available one-time funds that were not spent in 2024 which are just being rolled over for this year (FY 2025).

Recommendation:

Approval of the resolution.
